C. Discussion and Possible Action of School Closure in regard to COVID-19 – ACTION Superintendent Perry led the discussion on this item. To date, we have 25 confirmed COVID cases in the district and 81 confirmed staff that have either tested positive or are in quarantine.

Deputy Superintendent Tagle gave a report on school closures, quarantined staff and discussed the process for deep cleaning/disinfecting the buildings that have had to shut down. Director Lisa Patch has been working non-stop, tracking data, working with PED, etc.

Director Lisa Patch shared information about positive cases in the district reporting that since the beginning of school, there have been 25 positive cases, 10 adults and 15 students. Of the positive cases, 14 are attending hybrid. We are required to report cases that are completely virtual and have not been in the building. Eight of our locations have been affected by positive cases. Principals are doing a great job to minimize contacts. There were 146 close contacts to the 25 people that had tested positive. Of the 146, 81 are staff members and 65 are students. Nurses are working very hard and are continually assessing students as they come in. We have definitely seen an increase in COVID cases since Thursday, November 5 and continue to watch and monitor several potential cases.

Deputy Superintendent Malone gave the board an update on the impact on instruction as a result of the positive COVID cases and answered questions posed by the Board. It has become difficult to maintain leadership on our campuses. Deputy Malone reported that 63% of elementary principals are not in the building and 40% of middle school principals are not in the building because of COVID. Sierra Elementary school was closed this past Friday for in-person learning; students attended virtually that day. Attendance at Sierra has

been affected; a week ago there were 99 students and today's attendance was half of this. Teachers are beginning to feel uncertain and worried.

Sierra Principal Melissa Cole and Yucca Principal Catherine Diaz shared information on the impact the recent positive COVID cases have had at their schools and answered questions posed by the Board. Parents are beginning to feel nervous and are now requesting that their students return to virtual learning.

The Board shared their thoughts and discussed options for moving forward.

Vice-President Sherwood made a motion to return to virtual learning effective **Thursday**, **November 12, 2020** until the Board deems it safe for students to return. Secretary Teweleit seconded.

Executive Assistant Lisa Patterson conducted a roll call vote.

President Cadwallader voted "aye" Vice-President Sherwood – "aye" Secretary Teweleit voted "aye" Member Rabon voted "aye" Member Torres – "aye"

All Board members voted "aye", motion passes
