A. Introductions

1. Call to Order

President Rabon called this meeting to order at 6:00 p.m

Vice-President Sherwood made a motion to adopt the agenda. Member Torres seconded. Motion passed unanimously.

Secretary Teweleit made a motion to approve the meeting minutes. Vice-President Sherwood seconded. Motion passed unanimously.

C. Presentations/Recognitions

1. AHS MESA Robotics Team

Superintendent Moore introduced the AHS Robotics Team. Students introduced themselves and spoke about the program. The team performed at the BEST competition last month; this performance is what qualified them to the championships in Frisco this past weekend.

During the BEST Competition in November, the team placed as follows.

- Exhibit and Interviews-4th place
- Marketing Presentation-4th place
- Robot Performance-7th place
- Engineering Notebook-5th place
- BEST Award (overall) 5th place in New Mexico

The team scored many points and the robot performed better than previous years. They were one of four NM teams, out of 34 NM teams, who made it to the regional championships in Frisco, TX.

2. Ed Rising Program

Ed Rising Instructor Ms. Courtney Gagnon and a couple of her students shared information about The Educator's Rising Program, a nationwide program.

- The vision is to make a clear pathway in every school district in America for young people who want to serve their communities as highly skilled educators.
- Approximately 40 students are in the program
- The goal is to recruit youth from our community and to keep them in the community to become teachers
- Recruit teachers with a more diverse background
- Almost 60% of teachers teach within 20 miles of where they went to school
- The program is a community-based model in which chapters at schools feed teacher preparation programs at institutes of higher education with the support of the State Department of Education and local funders and foundations
- Students will be attending a state conference in Las Cruces in March, 2022.

3. AFJROTC Cadets

Superintendent Moore introduced the AFJROTC cadets and instructors Maj Odgers, MSgt Sanders. Cadets highlighted their recent accomplishments and were proud to announce that they placed 1st and 3rd overall in the State of NM in the individual drill routine where over 200 students competed. The cadets competed against 20 other schools around the state of NM. These students work very hard and are very dedicated. The JROTC mission is to develop citizens of character dedicated to serving our nation and community.

Superintendent Moore also shared information about FFA. Superintendent Moore was proud to announce that Executive Director of Health Services Lisa Patch just won the National Public Health Official of the Year Award and will receive her official award at a national conference in June.

1. Superintendent's Report - Dr. Ken Moore

Superintendent Moore reported as follows:

- A job fair is being held December 16, 2021 from 1:00-5:00 at the HUB (aka Building B on the corner of 12th and Florida)
- Mr. Billy Hays has been appointed as the Acting Athletics Director
- Ms. Pamela Renteria has been hired as the new Deputy Superintendent
- Ms. Danielle Kusmak has been hired as the new MVMS Principal
- Superintendent Moore expressed appreciation to Board Member Anthony Torres for serving on the Board and for all he has done for the school district.
- Our enrollment at AHS increased and as a result NMAA moved us to a 6A Classification
- In January, we will have two to three work sessions to discuss strategic planning
- A Holloman Parent Forum was recently held and went very well
- Construction of Holloman Elementary remains on schedule and as of November 30, construction is 40% complete.
- Scheduled substantial completion date remains 1 Aug 2022
- The new Alamogordo Middle School (CMS replacement) Schematic Design phase is complete
- Negotiations with PSFA and PSCOC regarding State funding participation is ongoing
- For Holloman MS, we have received feedback and additional questions from the Federal Review Committee regarding the grant proposal
- Several revisions are required and updates are being made by our consultants as quickly as possible
- A meeting is scheduled for 20 Dec to present our NEPA position to the federal team and develop consensus on the path forward
- For the Sacramento Site, demolition is complete and the design and pricing to renovate the landscape, playground, and basketball court areas is in progress; project is anticipated to begin in early spring of 2022

Col Nicholas Pederson expressed appreciation for hosting the Holloman Parent Forum and for listening and addressing parent concerns.

3. Student Ex-Officio Member's Report - Nathaniel Calentine
