4. Consider approval of the 2020-2021 Operating Budget for Alamogordo Public Schools – ACTION

Mr. Bryan Runyan gave the Board an overview of the 2020-2021 operating budget and answered questions posed by the Board. The state equalization guarantee unit value was increased by 3.39% from last year. Mr. Runyan also discussed the minimum salaries for staff.

President Cadwallader noted that the 2020-2021 Operating Budget is being conditionally approved pending final approval by the Public Education Department with possible budget changes

5. Consider proposed adoption of Instructional Materials for Mathematics - ACTION Presented by Deputy Superintendent Cara Malone

Deputy Superintendent Malone gave the Board a presentation on this item. The adoption math team consisted of Curriculum Director Andrew Coleman, Teaching & Learning Coach Laura Kirkpatrick, APS Teaching & Learning Coaches and a selection of a K-12

teacher team. Deputy Malone discussed the adoption framework and process. The recommendations for math instructional resources were as follows.

Elementary Recommendation: Houghton Mifflin: Expressions Middle School Recommendation: McGraw Hill: Reveal Math and ALEKS High School Recommendation: McGraw Hill: Reveal Math and ALEKS

Member Rabon made a motion to approve the Consent Agenda. Vice-President Sherwood seconded.

President Cadwallader reitered that the 2020-2021 Operating Budget is being conditionally approved pending final approval by the Public Education Department with possible budget changes

C. Graduation Update

AHS Principal Dr. Kenneth Moore gave the Board an update on graduation. A virtual graduation is scheduled for May 22, 2020 at 6:00 p.m. Each student will have their own slide that will display their name and picture. Students also have the option to upload a 10 second video. A link, via You Tube, with more details will be sent out to give families the opportunity to watch. A graduation walk is tentatively planned from May 18 to May 22 where 2 students, per every 15 minutes, will have the opportunity to walk across the stage to receive their diploma. A limit of 5 people per family (graduate and 4 guests) will be allowed on the field. This is contingent upon the Governor's health restrictions. Principal Moore went over the number of seniors graduating. There are 275 seniors graduating (a graduation rate of 92.3%) for the class of 2020.
