## E. Reports

### 1. Superintendent's Report - Acting Superintendent Pam Renteria

Acting Superintendent Pam Renteria's report began with a report from Deputy Superintendent Colleen Tagle. Deputy Superintendent Tagle provided an update on Transportation, Student Nutrition, and the on-going Construction Projects and answered questions posed by the Board. Renovations will soon begin to upgrade the parking area that is located behind the AHS Tiger Stadium. North, La Luz, Buena Vista, Sierra, High Rolls Mountain Park, Yucca, Chaparral Middle, Mountain View Middle, and Stepping Stones will all be receiving virtual security vestibules which will consist of video cameras and electronic doors. This project will be completed around the October/November time frame. Deputy Tagle reminded the Board that capital improvement and construction projects across the district can be found on our construction website at [www.allin4ourkids.org](http://www.allin4ourkids.org).

Acting Superintendent reported as follows.

- Today's tour of the new site for Chaparral Middle School went very well
- Had a wonderful tour of Holloman Elementary School with the Undersecretary of Defense, The Honorable Gilbert Cisneros, the Assistant Secretary of the Air Force, The Honorable Alex Wagner, along with Col Spears, Chief Martin, President Rabon, and LaurieAnn Goodier.
- A Listening Session with LESC (Legislative Education Study Committee) will take place on August 25, 2023 from 3:00 - 4:30 in the APS boardroom and is open to the public
- Current enrollment without Pre-K is 5350; with Pre-K, we have 5530
- Acting Superintendent Renteria was proud to report that we currently have 12 teacher vacancies in the district and only 10 educational assistant vacancies; 5 schools are fully staffed, which is amazing
- We had 71 new teachers at our New Teacher Academy this year and 30 mentors to support these new teachers
- All local sporting events will be free this year
- Expressed a heartfelt appreciation to the staff involved in making the big fun chairs that were placed at the elementary schools on the first day of school

### 2. Holloman Ex-Officio Member's Report - Col Rosales

Holloman Ex Officio Member Col Rosales reported as follows.

- Col Rosales expressed his appreciation to the leadership of the Holloman Schools for a successful clap-in event on the first day of school
- The Crisis Action and Response teams have recently been meeting to discuss how to better improve support and relationship building to work together to figure out more opportunities where Holloman can assist.
- Guest speakers from the Holloman Team will be visiting AHS between August 21-25
- U.S. Air Force Academy Band will be visiting one of the elementary schools on September 22, 2023
- Holloman is in the process of restarting the Squadrons in Schools Program

Student Ex-Officio Member Olivia Goodier provided an update on upcoming athletic

sporting events and activities. Olivia expressed her appreciation to Mr. David Maldonado, Head Athletic Trainer and Misa Tran, Assistant Athletic Trainer for their hard work these past few weeks to ensure students are transferred from rank one to healthy roster. Homecoming Game is on September 1, 2023. Olivia has reached out to middle school principals to gather information to report on at the September Regular Board Meeting.
