

AMENDMENT #001 TO

ALAMOGORDO PUBLIC SCHOOLS PROFESSIONAL SERVICES CONTRACT NO.001-2021-04-C3

THIS PROFESSIONAL SERVICES CONTRACT (the "Contract") is amended this 21st <u>day of June, 2023</u> ("Effective Date") by and between the Alamogordo Public Schools ("District"), a New Mexico public school district, whose address is 1211 Hawaii Ave, Alamogordo, New Mexico, and <u>New Direction Solutions, LLC dba ProCare Therapy</u> ("Contractor"), an LLC with its principal place of business at 1979 Lakeside Parkway, Suite 900, Tucker, GA 30084 (herein referred to individually as "Party" or collectively as "Parties").

WHEREAS, the District requires certain professional services for <u>Ancillary and Related Professional Services for Special Education</u> as set forth in its <u>Professional Services Contract No. 001-2021-04-C3</u>; and

WHEREAS, Contractor submitted a proposal to provide such professional service for <u>Ancillary</u> and <u>Related Professional Services for Special Education</u> and Contractor represents that it has the experience, licenses, qualifications, staff and expertise to perform said services in a professional and competent manner;

NOW, THEREFORE, it is mutually agreed by the District and Contractor that for the considerations set forth herein, Contractor shall provide said services to the District as set forth below and in **Professional Service Contract No. 001-2021-04-C2.**

Term

The Term of this Contract commenced on <u>July 1, 2022</u> and ends on <u>June 30, 2023</u>.

Compensation

For the Work deemed satisfactorily rendered, the District agrees to pay the Contractor compensation <u>as amended</u> as follows: <u>An additional amount not to exceed \$100,000, not including Gross Receipts Tax is added to the original authorized contract amount of \$200,000, for a new contract total not to exceed \$300,000 not including Gross Receipts Tax for the remainder of FY 2022-2023.</u>

All other terms and conditions of original contract No. 001-2021-04-C3 remain in effect.

The District and the Contractor have entered into this Contract as of the Effective Date.
