President Cadwallader called this meeting to order at 6:06 p.m

4. Adoption of Agenda – ACTION

Vice-President Murphy made a motion to approve the agenda. Secretary Danekas seconded. Motion passed unanimously.

Member Wright made a motion to approve the meeting minutes. Vice-President Murphy seconded. Motion passed unanimously.

C. Presentations/Recognitions

1. Presentation: First Savings Bank Donation to Alamogordo Public Schools – School Debit Card Program

Mr. Reid Griggs, President of First Savings Bank presented a check in the amount of

\$ 2722.77 to the District. These are funds that are earned through their Tiger Debit Card Program, a program that was started 5 years ago. Each time a customer uses their special Tiger debit card, the bank earns money through an interchange fee. The bank donates 10% of this earned money to Alamogordo Public Schools.

2. Presentation: AHS Engineering/MESA Students

Ms. Daniela De Santiago introduced and recognized students that are currently in her program. One of her students, Mark Allen, gave the Board an overview of the development of a prosthetic for an Alamogordo High School student. Since then, they have collected market research and professional insight on how to implement and build this prosthetic.

3. Presentation: ASTRO Robotics

Dr. Sarah Cerra gave the Board an overview of the A.S.T.R.O. Robotics Program and introduced students in the Short Circuits, SupercalifragilisticA.S.T.R.O.alidocious and the A.S.T.R.O. Vikings programs. Each student shared information about these programs and highlighted future plans to expand and improve the programs.

The group will be representing the state at World Championship in Houston in April. Dr. Cerra also spoke about the hope of developing a program that would allow the participation of all APS elementary schools next school year.

4. Presentation - Love INC of Otero County-Backpack Program

Susan Payne, Executive Director of Love INC, provided an overview of the program and introduced some of the 30 volunteers who assist those in need. Love INC. was started in 2009 and was created out of a vision of local churches to connect churches and services to meet the needs of those less fortunate in our community. Love INC bridges the GAP between those in need and the resources to assist. Executive Director Payne spoke about the community classes and outreach programs Offered through Love INC. The backpack weekend food program is a huge success and is a great partnership with the school district. It was launched in January, 2011 with an approximate total of 21 bags provided each week to three schools in the Alamogordo Public Schools. Currently, the program provides approximately 237 bags each week to Alamogordo and Tularosa districts, grades K-12. Love INC is privately funded by the community and local businesses.

E. Reports

1. Superintendent's Report - Acting Superintendent Michael Crabtree

Acting Superintendent Crabtree reported as follows:

- Was pleased to report that AHS Culinary Teacher, Mr. Walter Aleluya was named CTE Teacher of the Year by the NM Association for Career & Technical Education. The official award from the Association will be presented to Mr. Aleluya at a later date.

- The Alamogordo Community recently received the Altus Trophy Award for their support to Holloman AFB. The nomination package consisted of the many partnerships between Holloman and the Alamogordo community, from education, housing, on and off base volunteering, military spouse employment, and military construction projects. The Altus chamber partners with Air Education and Training Command officials each year to recognize a community that goes above and beyond. What an outstanding celebration of the Alamogordo community!
- This month is *Love the Bus* Month. Acting Superintendent Crabtree expressed appreciation to Transportation Coordinator, Mr. Donovan Balsley and his team for the great job they do and the efforts they do to keep students safe every day.
- This month is *Kindness* Month. Thank you to Executive Director Lisa Patch and her team for the many activities and challenges held this month to spread kindness awareness throughout the district.
- Expressed appreciation to school resource officers, Officer Escalante and Officer Alonzo. We appreciate everything they do.
- 6th Annual Alamo Innovate & Educate Professional Development Opportunity will be held on 2/28/24 with keynote speaker Gerry Brooks
- Provided an overview of state data highlighting school designations. Holloman Middle, Sierra, High Rolls and Buena Vista all ranked as Schools of Excellence. Holloman Elementary was ranked as a Spotlight school, and all other schools ranked as Traditional schools
- Expressed appreciation to Student Nutrition Coordinator Sandra Davis for applying and receiving a student nutrition grant for 1.4 million. The grant is intended for school kitchen infrastructure and equipment. The five schools that will benefit from this grant include Buena Vista, La Luz, Sierra, North, and Yucca.
- Acting Superintendent Crabtree shared attendance (excused/unexcused) and truancy data reporting that last year we ended with a 9.75% district wide that were chronically absent. Our goal is to be at 5% or below. We currently have 5 schools that are below 5%, 3 schools between 5% and 10% and 5 schools between 10% and 15%.
 - Truancy Officer Charles Turpin works closely with Data Assessment Coordinator, Carrie Rowe and Admin staff to review data, student cases, and to discuss interventions to offer support for improving student attendance.

2. **Holloman Ex-Officio Member's Report - Col Rosales**

Col Rosales spoke about the Starbase Program and stated that they may have some space to assist Dr. Sarah Cerra and the Robotics Program. April is the Month of the Military Child with many activities taking place throughout the month of April. APS designates April 25th as the military child day of celebration with various events taking place at the schools. Col Rosales spoke about the The Purple Star Program, a program that publicly recognizes and designates schools that meet certain requirements which schools are the most committed and best equipped to meet military-connected students and their families' needs. The three schools designated as Purple Star Schools are Alamogordo High School, Holloman Middle School, and Holloman Elementary School. APS was the first district in New Mexico to go forth and figure out what a

Purple Star Program was. Col Rosales briefly spoke about the Project Search Program, a program for 18-22 year old developmentally delayed individuals.

3. Student Ex-Officio Member's Report - Olivia Goodier

Student Ex Officio Olivia Goodier reported on student sports activities being held throughout the secondary schools. The recent Winter Wonderland was a huge success!
